*You are hereby notified that I have amended Certificate of Approval No. 6925-6REN9E
issued on December 1,
2006 for one (1) Energy-From-Waste Demonstration Facility , as follows:*

The following Terms and Conditions in the *Certificate*, Notice No. 4 issued October 24, 2008 has been removed:

"(15) The re-routing of the exhaust of the engine equipped with a catalytic converter to the enclosed flare for further combustion shall expire after six (6) months from date of this *Notice No. 4*. "

and replaced by the following Terms and Conditions:

"(15) The re-routing of the exhaust of the engine equipped with a catalytic converter to the enclosed flare for further combustion shall expire after twelve (12) months from date of this *Notice No. 4*. "

all in accordance with the Application for Approval (Air & Noise), dated April 8, 2009 and signed by Ken Campbell, PLASCO Trail Road Inc., and all supporting information and documentation associated with the application.

All other Terms and Conditions in the *Certificate* remain the same.

This Notice shall constitute part of the approval issued under Certificate of Approval No. 6925-6REN9E dated December 1, 2006.

In accordance with Section 139 of the Environmental Protection Act, R.S.O. 1990, Chapter E-19, as amended, you may by written notice served upon me and the Environmental Review Tribunal within 15 days after receipt of this Notice, require a hearing by the Tribunal. Section 142 of the Environmental Protection Act, provides that the Notice requiring the hearing shall state:

1. The portions of the approval or each term or condition in the approval in respect of which the hearing is required, and;
2. The grounds on which you intend to rely at the hearing in relation to each portion appealed.

The Notice should also include:

3. The name of the appellant;
4. The address of the appellant;
5. The Certificate of Approval number;
6. The date of the Certificate of Approval;
7. The name of the Director;
8. The municipality within which the works are located;

And the Notice should be signed and dated by the appellant.
